# **About Dane County Dog Parks**

Dane County was the first park system in the United States to develop an off-leash dog park program. We now have eight off-leash dog parks, totaling 268 acres, each with its own unique features and terrain.

## **Dane County Dog Permit**

A Dane County dog permit is required in order to bring your dog to a dog park within the **Cooperative Dog Park Program** which includes: Dane County Parks, City of Madison Parks, City of Sun Prairie Parks and City of Middleton Parks. Dog parks in other municipalities have their own permit system and are not part of the cooperative program.

The dog permit also allows you to access over 14,000 acres of land within the Dane County Park System for on-leash hikes with your pup. Dogs must remain on-leash unless at a dog park for the safety and enjoyment of other park users.

# **Licensing Requirements**

To purchase a dog permit, you will **FIRST** need a dog license from your local municipality. All dogs in Dane County are required to be licensed by the age of 5 months. To obtain a dog license contact your town, city or village clerk. The license number is required to purchase a dog permit.

# Dog Park Etiquette

#### RULES

- Dog owners are legally and financially liable for injuries/damages caused by their dog(s).
- All dogs must be legally licensed and vaccinated and must wear a visible municipal license and ID tag.
- A Dane County Daily or Annual Park Dog Permit is required.
- Aggressive dogs are prohibited from the park. Any dog exhibiting aggressive behavior must be removed from the park immediately.
- Female dogs in heat are not allowed in a dog park.
- Dog waste must be cleaned up and placed in the proper receptacle by the owner/handler. This is essential to the ongoing success of the dog park.
- The owner/handler must be in control of their dog(s) at all times. The dog must be within view and under voice control of the owner/handler.
- Dogs must be leashed with a 6-foot static lease when entering and leaving off-leash area. The owner/ handler must have a leash in their possession at all times.

#### RECOMMENDATIONS

- Limit treats and toys brought into a dog park as it may attract other dogs or lead to possession aggression.
- Make sure your dog is healthy. It is possible for your dog to pass on an infection or parasite to other dogs. Sharing water can also lead to disease transmission.
- Children should be supervised when in the dog park.
- Do not bring more dogs than you can effectively restrain. It is recommended that you bring no more than three dogs at one time.
- You are responsible for all actions of your dog and must stay with your dog. A dog park is not the place to work on behavioral problems with your dog.
- Do not let your dog come into contact with wild animals.
- Do not dump pet waste from offsite at the dog park.
